## TWINNING INSTITUTIONAL BUILDING INSTRUMENTS IN UKRAINE






Twinning is an institutional building instrument that provides framework for cooperation between civil servants of Ukrainian and EU Member States government authorities. Twinning instrument provides long-term assistance (on average, the preparation of the Twinning project takes 1–1.5 year and the implementation period takes 1–2 years) with the aim to implement elements of public administration needed for adaptation of the national legislation to the EU norms and standards.

National Agency of Ukraine on Civil Service (hereinafter — the NAUCS) is the coordinator for the Institution Building Instrument Twinning implementation according to the Decree of the President of Ukraine "Issue of the Twinning program in Ukraine" dated from October 6, 2005 No 1424.

Use of this instrument in Ukraine is regulated by Resolution of the Cabinet of Ministers of Ukraine as of October 11, 2016 No 700 "On Approval of the Procedure for Initiating, Preparation and Implementation of Twinning" and interdepartmental order of the NAUCS and Ministry of Economic Development of Ukraine as of June 15, 2012 No 120/702 "On establishment of the Twinning Programme Coordination Group".




As of April, 2018: 42 Twinning projects are successfully completed, 11 projects are at the stage of implementation in the Twinning Work Plan and 10 projects are at the stage of preparation of the Twinning Fiche. The total number of Twinning projects are 63.

# In the framework of Twinning programing in 2017 NAUCS received 58 project proposals from 30 government authorities.

On 30 November 30, 2017 meeting of the Working Group on Coordination of Twinning and TAIEX Instruments Implementation took place. 5 project proposals were approved:

- «Strengthening institutional capacity of the Ministry of Economic Development and Trade
  of Ukraine by ensuring effective functioning of national quality infrastructure in Ukraine»
  (Ministry of Economic Development and Trade of Ukraine);
- «State Market Surveillance in Ukraine» (Ministry of Economic Development and Trade of Ukraine);
- «Support to the Ministry of Regional Development Construction, Housing and Communal Services of Ukraine in improvement of the current municipal waste management system and introduction of effective separate collection of specific waste streams in municipal waste» (Ministry of Regional Development, Construction, Housing and Communal Services of Ukraine);
- «Support of Border Guards Human Resource Management System» (Administration of the State Border Guard Service of Ukraine);
- «Strengthening of regulatory and legal capacity of the National Commission for State Regulation of Communications and Information with regard to the implementation of telecommunication services quality of service (QoS) monitoring system» (National Commission for the State Regulation of Communications and Informatization).
