Active, powerful and developed civil society is considered to be an important element of any democratic state as well as it plays one of the leading roles in implementation of urgent social changes and good governance, in public affairs and solving local problems, development and realization of effective state policy in different areas, approval of responsible law-governed state before the citizen, in solving political, social and economic and humanitarian problems.

Revolution of Dignity has opened a new stage in the history of civil society development as well as demonstrated the impact of civil society on social and political transformations became an impulse for renewal and reorganization of the government.

Taking into account implementation of the EU-Ukraine Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and Ukraine, of the other part, new challenges within the framework of interaction between the government and the civil society have emerged. They were faced due to the necessity of implementation of European rules and approaches to such kind of interaction that is based on principles stipulated in the Association Agreement. Furthermore, it is of urgent importance to enhance cooperation between civil society institutes of Ukraine as well as the EU Member States.

According to the experience of democratic states, the civil society development under systemic state support gives an opportunity to involve additional human, organizational, financial and technical resources for social and other socially significant services, support to the process of decentralization of public administration and improvement of its quality as well as it decreases public spending and prevents corruption risks.

### PRESIDENTIAL ADMINISTRATION OF UKRAINE

### THE CABINET OF MINISTERS OF UKRAINE

### COMMITTEE OF THE VERKHOVNA RADA OF UKRAINE ON HUMAN RIGHTS, NATIONAL MINORITIES AND INTERNATIONAL RELATIONS

- observance of the rights and freedoms of human and citizen
- activity of Ukrainian Parliament Commissioner for Human Rights



### UKRAINIAN PARLIAMENT COMMISSIONER FOR HUMAN RIGHTS

- promoting legal awareness of the population and protection of confidential information about a person
- parliamentary control over the observance of the right to access to public information



### THE CABINET OF MINISTERS OF UKRAINE

- state control over ensuring access to information by managers of information
- monitoring the implementation the Law of Ukraine "On Access to Public Information" by executive authorities and monitoring of judicial decisions made due to the violation the right to receive public information, preparing proposals for improving the Law



### STATE AGENCY FOR E-GOVERNANCE IN UKRAINE

- functions of General state customer of the National Informatization Program
- monitoring of the content of official executive authorities' web sites
- creation and ensuring the functioning of the Unified State web portal of open data
- realization with the involvement of institutions of a civil society and public representatives of periodic monitoring of the state publication and updating of data sets on the official executive authorities' web sites and on the Unified State web portal of open data



### DEPUTIES OF LOCAL COUNCILS, NON-GOVERNMENTAL ORGANIZATIONS, COMMUNITY COUNCILS, CITIZENS

- public control over ensuring access to public information by managers of information



### ACCESS TO PUBLIC INFORMATION

- publishing the information about public authority and approved decisions
- systematic accounting of documents in the possession of a public authority
- accounting of information requests
- definition of special places for applicants with the documents or their copies
- definition of special structural units or destination responsible persons for the applicants access to information and publication of information
- responding to information requests
- preparation and publication of reports on the processing of requests for information



### PUBLIC CONSULTATIONS

- preparation of tentative plan of consultation with community
- training on propositions of public council proposals to the heads of state executive bodies concerning to the organization of public consultation
- preparation and publication information reports of conduction consultations with community
- organization the conduction of public events within consultations with public
- publishing protocols on results of public events on official website
- publishing reports on the results of consultations with community
- monitoring and analysis public opinion



### PRESIDENTIAL ADMINISTRATION OF UKRAINE

- publication of the draft laws of Ukraine and draft acts of the President of Ukraine, which require wide discussion



### STATE AGENCY FOR E-GOVERNANCE OF UKRAINE

- roviding functioning of the Single Web site of the Cabinet of Ministers of Ukraine with the ability to integrate information resources of central and local executive authorities placed in Internet



### NATIONAL AGENCY OF UKRAINE ON CIVIL SERVICE

- approves the Standard procedure of public report of the head of state executive authority
- together with the Ministry of Education and Science of Ukraine provide in the process of preparation, retraining and advanced training of civil servants in the field of "Public Administration" more profound study of modern communication technologies, methods of attracting public participation in formation and implementation of state policy, analysis of public opinion and conducting the mass media monitoring



### CABINET OF MINISTERS OF UKRAINE

- involvement in decision-making on matters relating to the formation and implementation of state social and economic policies, regulation of labor, social and economic relations, national trade unions, associations and national associations of employers



### SECRETARIAT OF THE CABINET OF MINISTERS OF UKRAINE

- to ensure coordination of functioning of the Single Web Portal of Cabinet of Ministers of Ukraine, its content, technical support, maintenance and setting regulations and information exchange standards between its constituent parts
