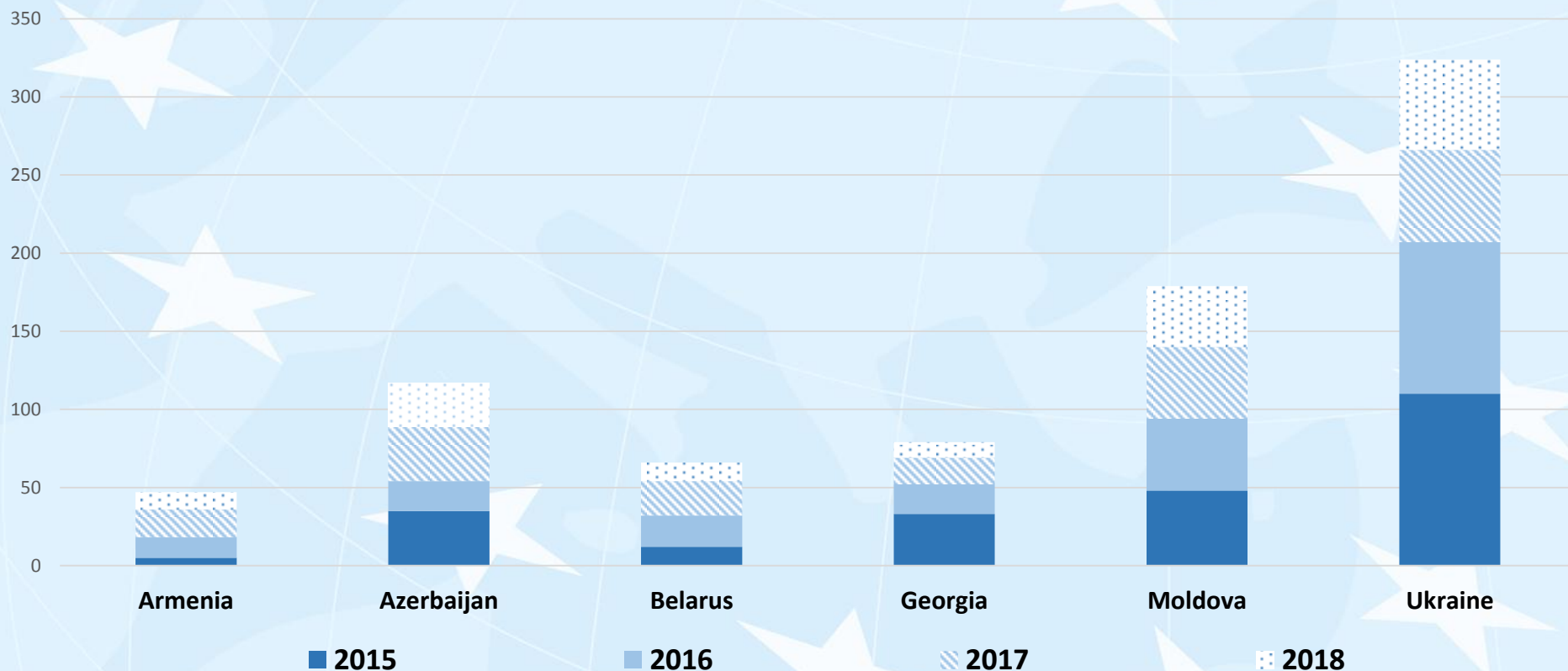

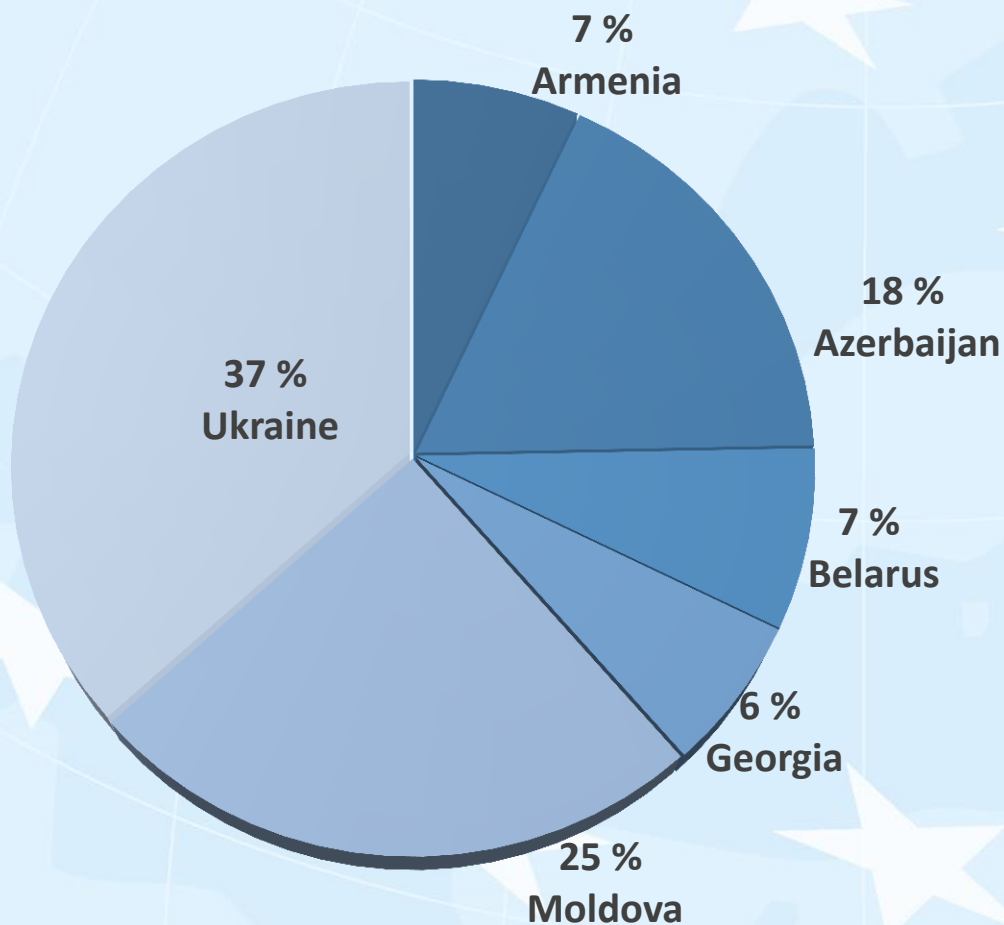


## All TAIEX activities in countries of the EU initiative “Eastern Partnership” (2015–2018)



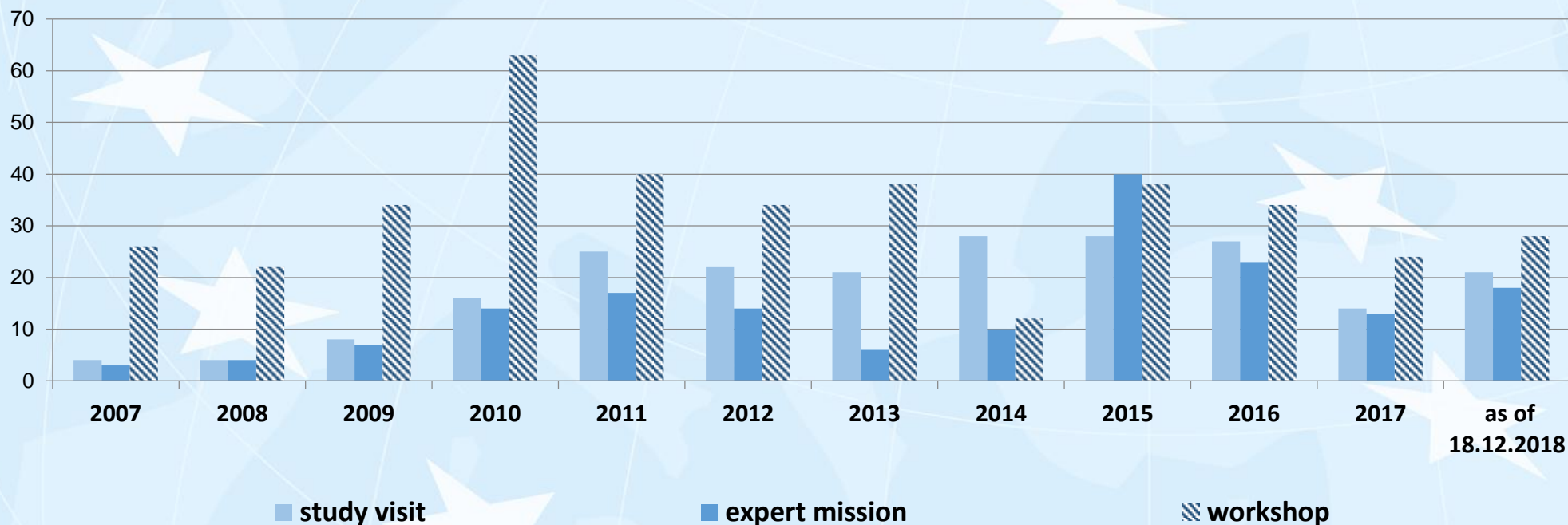

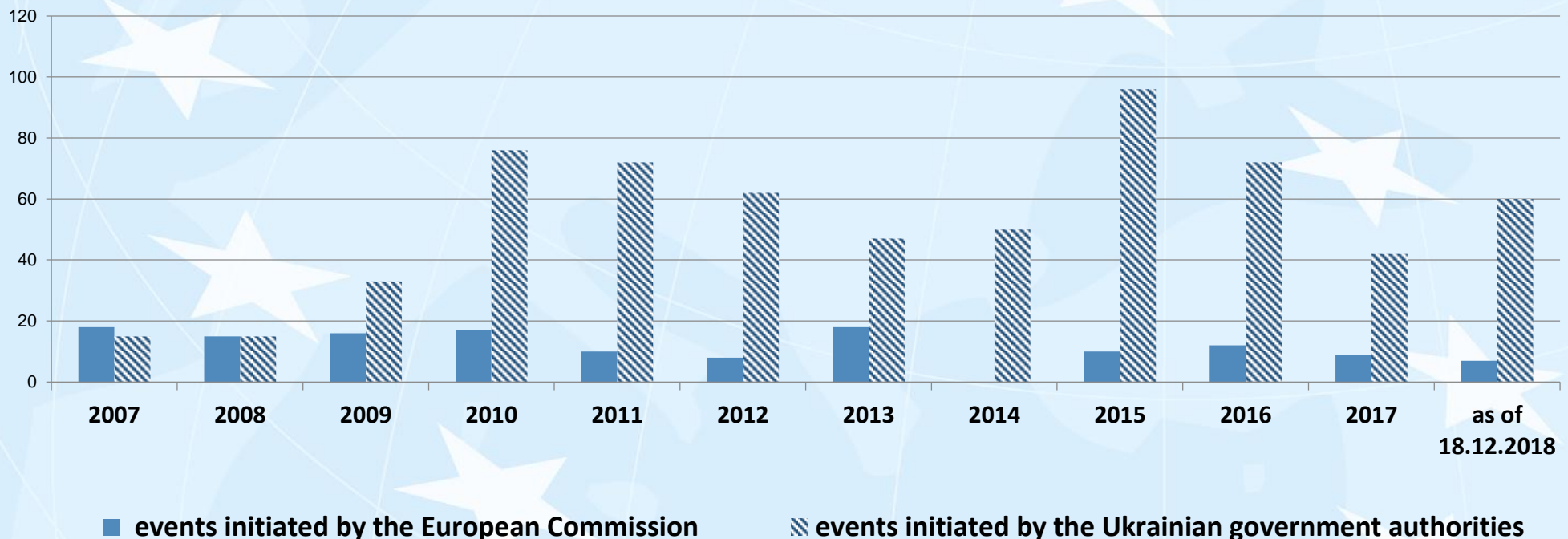
## TAIEX activities in Ukraine per type of events (2007 – 18 December, 2018)



Since the beginning of implementing the TAIEX instrument in Ukraine, as of **18 December, 2018** *18 069 representatives* of Ukrainian government authorities participated in *790 events* organized in the framework of the TAIEX implementation.



## TAIEX activities in Ukraine per the initiator (2007 – 18 December, 2018)



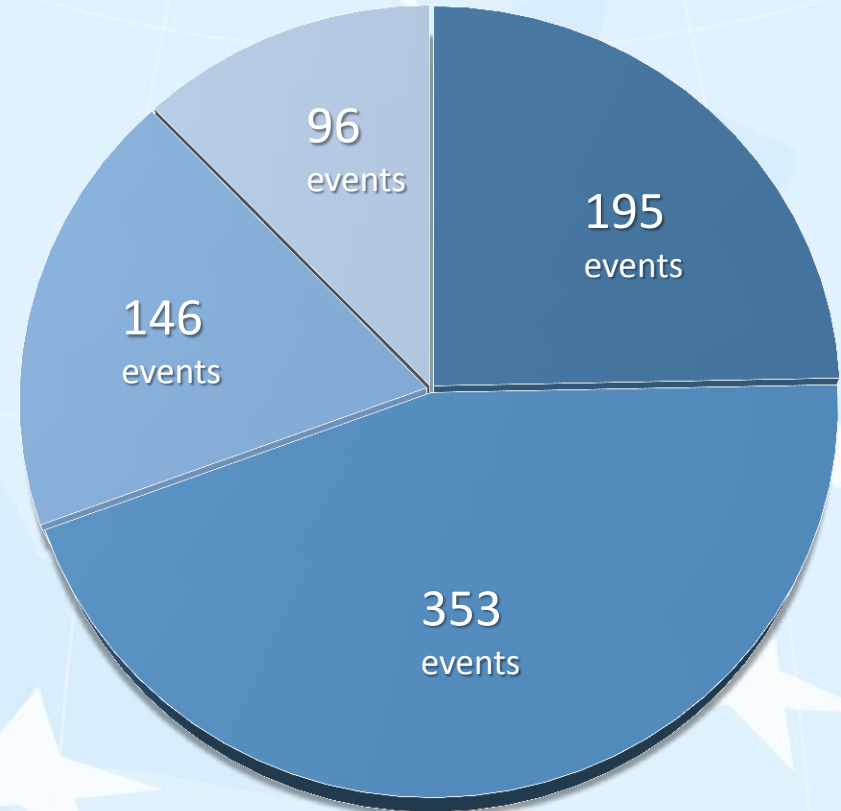
● 148 events initiated by the European Commission

## TAIEX activities in Ukraine per sector (2006 – 18 December, 2018)

**During the mentioned period TAIEX events were conducted in the following areas:**

- Justice and Internal Affairs (195 events);
- Internal Market (353 events);
- Environment, Telecommunications, Transport (146 events);
- Agriculture and Food Safety (96 events).



## TAIEX activities in Ukraine per type of events in 2018

**In 2018, 60 TAIEX events were  
conducted in Ukraine:**

- 21 workshops;
- 19 study visits to EU Member States;
- 17 expert missions to Ukraine.

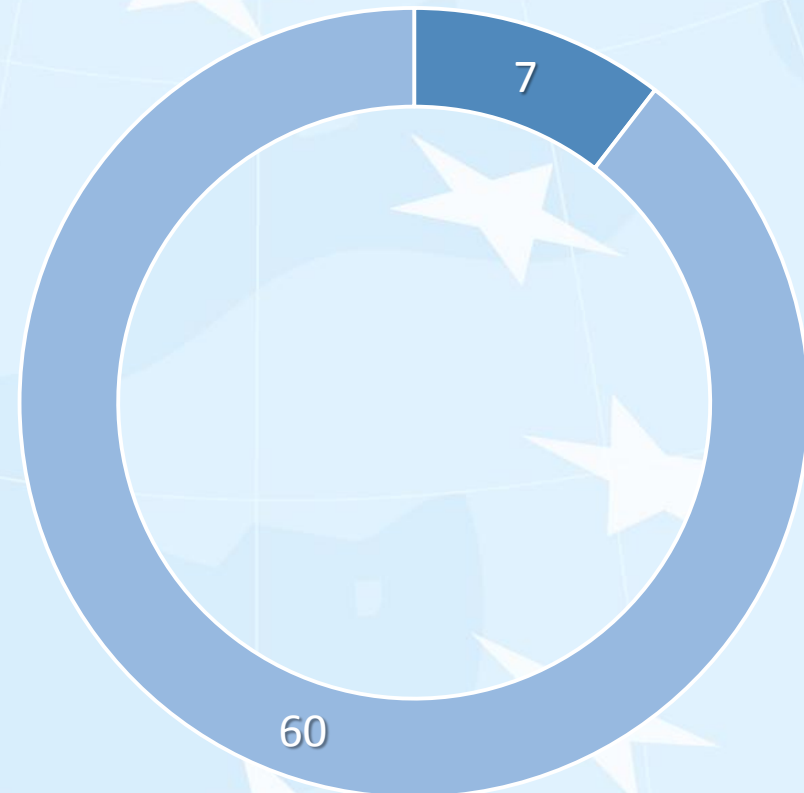




## TAIEX activities in Ukraine per the initiator in 2018

7. Transboundary Animal Diseases (04-05.12.2018)

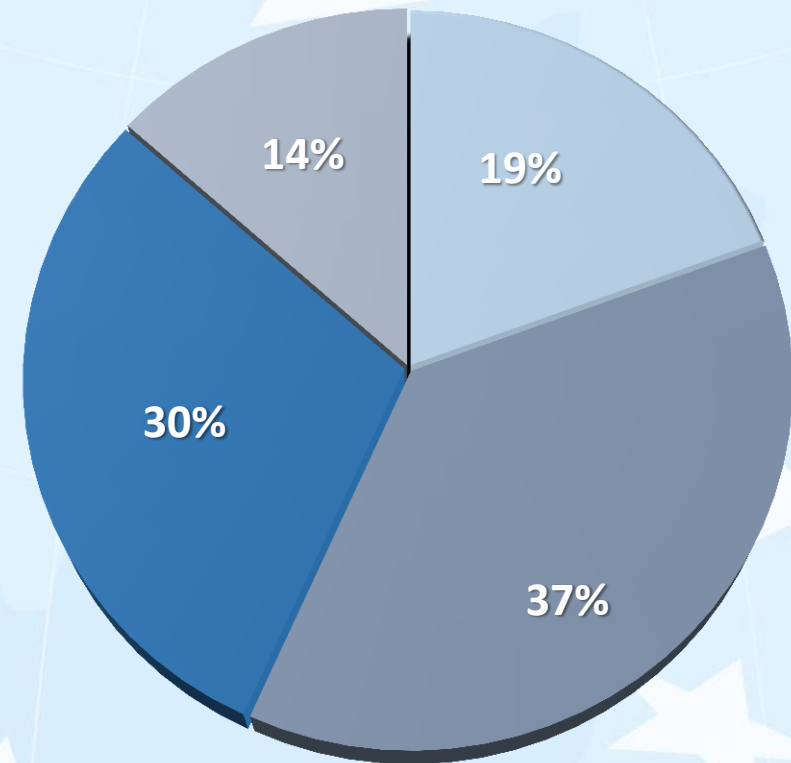




## TAIEX activities in Ukraine per sector in 2018
